ORDER

UPON hearing Mr. Wayne Nordé, Counsel for the Applicant

And Ms. Marie Louise Pierre-Louis, State Attorney, for the Respondant.

UPON THE APPLICATION of Mandell Joseph Cyrille as by way of Fixed Date Claim Form and Notice of Application for an Order to be admitted to bail pending appeal filed on the 11th April 2022, coming up for hearing.

IT IS HEREBY ORDERED that:

This application for bail is hereby granted. The Applicant is therefore released on a recognizance of bail as follows:

Bail is set in the total amount of \$100,000.00 bond with no cash deposit. There shall be one (1) suitable surety liable. The Applicant shall be bound by the following conditions:

(a) The Applicant shall report to and sign in at the Vielle Case Police Station every Monday, Wednesday, Friday and Saturday between the hours of 6:00 AM and 6:00 PM, commencing immediately upon his release from custody.

(b) The Applicant shall reside with his mother, Anne Marie George, in Vielle Case, Dominica.

(c) The Applicant shall not contact or communicate in any way either directly or indirectly by any physical, electronic or other means with the complainant, Kevin George.

(d) The applicant shall not be within 100 feet of the complainant, Kevin George, nor any place where the complainant lives, works or goes to school.

(e) The Applicant shall not possess any weapon, firearm, pellet gun, flare gun, imitation firearm, prohibited weapon, restricted weapon, bladed weapon, ammunition or explosive substance, or anything designed or intended to be used to cause death or injury.

(f) The Applicant shall not possess or apply for any license, authorization or registration certificate for any such weapon referred to above.

(g) The Applicant shall remain within the Commonwealth of Dominica.

(h) The Applicant shall deposit his passport and any other travel permits or documents with the High Court Registry Office immediately upon his release from custody.

(i) The Applicant shall not apply for a passport or any other travel permits or documents while this case remains outstanding.

(j) The applicant shall keep the peace and be of good behavior.

(k) The applicant shall surrender himself into custody at the State Prison, Stock Farm, between the hours of 09:00 am and 12:00 pm, on the day before the date scheduled for the hearing of his appeal

(l) A breach of any of the terms of this Recognizance of Bail shall result in the immediate revocation of bail and the associated bond shall be subject to estreatment proceedings.
